CONSENT DECISION

WHEREAS, each of the parties has requested that this stipulated Consent Decision be entered in the above-styled action in accordance with 7 C.F.R. §1.138, the following is Decided:

The parties admit that this case is properly filed with the United States Department of Agriculture's Office of Administrative Law Judges ("OALJ"), by delegation from the Secretary of Agriculture, and that the OALJ has jurisdiction to hear this case based upon section 515(h) of the Federal Crop Insurance Act ("Act") (7 U.S.C. § 1515(h) and 7 C.F.R. § 400.454(f).

The parties agree that Respondent, Jeffrey L. Robertson, shall be disqualified from participating in any program, or receiving any benefit, under the Act for a period of one (1) year from the date of this Consent Order.

It is further agreed by the parties that Respondent, Jeffrey L. Robertson, shall pay a fine of Ten Thousand Dollars (\$10,000) to the Federal Crop Insurance Corporation ("FCIC") on or before June 1, 2012.

The parties hereto consent to the issuance of this agreed decision without further procedures or admissions or statements by either party. Both parties also agree that this Consent

Decision is not and shall not be construed as an admission by the Respondent of guilt or the validity of any claim asserted or of Respondent's liability.

THEREFORE, it is found that pursuant to section 515 of the Act, Respondent is disqualified from participating in any program, or receiving any benefit, under the Act for a period of one (1) year from the date of this Consent Order and shall pay a fine of Ten Thousand Dollars (\$10,000) to the FCIC on or before June 1, 2012.

This Order shall have the same force and effect as if entered after full hearing. The provisions of this Order shall become final and effective upon issuance (7 C.F.R. §1.138).

Copies of this decision shall be served upon the parties.
