SUBJECT: AOP No.11: Funding Agency and Funding Office Identifiers in the
Federal Procurement Data System - Next Generation

◆ **PURPOSE:** The purpose of this Acquisition Operating Procedure (AOP) is to provide a list of the Funding Agency and Funding Office Identifiers (IDs) in the Federal Procurement Data System - Next Generation (FPDS-NG) for the program offices of Departmental Management and the Staff Offices that provided the funds to obligate the contract.

◆ **EFFECTIVE DATE:** This AOP is effective on August 11, 2015.

◆ **REVISIONS:** *Subject:* Changed Funding to "Funding Agency and Funding Office."
Purpose: Revised the entire paragraph. *Procedures:* Revised in its entirety to separate and numbered the paragraphs. *Attachment 1:* Added the OSEC code.

This AOP replaces AOP No. 11, dated August 8, 2013.

◆ **AUTHORITIES:** FAR Subpart 4.6; and AGAR 404.6, Contract Reporting.

◆ **PROCEDURES:**

1. In FPDS-NG, the Contracting Officer (CO) must enter the proper Funding Agency ID and Funding Office ID for the office providing the funds obligating the contract transaction. If the funds for the contract transaction are provided by another agency, the CO must enter the Funding Agency ID and Funding Office ID that identifies the agency providing the funds.
2. The CO may use the ellipses button next to the field to find the appropriate Funding Agency ID and Funding Office ID for the program offices of the Departmental Management and the Staff Offices, and all other agencies.
3. The Funding Agency and Funding Office IDs for the program offices supported by contracting staff in the Procurement Operations Division, National Information Technology Center, and National Finance Center are listed in Attachment 1.

◆ **EXPIRATION DATE:** This AOP will remain in effect until canceled.
